PROPOSED ORDER PURSUANT TO STIPULATION, IT IS ORDERED THAT all proceedings in this case are stayed pending institution decisions by the Patent Trial and Appeal Board on the *Inter Partes* Re-views submitted by Defendant. The Court understands that decisions on the *Inter Partes* Reviews are statutorily required to be made on or before September 4, 2020. On September 14, 2020 or earlier, the parties shall provide a joint status report to the Court reporting the PTAB's institution decisions and setting forth the parties' views on how the litigation should proceed.
